# Annual Meeting of the Parish Council

# **Geldeston Village Hall**

# 23<sup>rd</sup> May 2022 7.30 PM

Parish Councillors present: I. Ansell (chairman), J. Ashfield, J. Hayward, L. Rowntree, D. Shave and A. Wade.

Please note that the previous planned meeting ended after item 1 as the Councillors could not agree on the appointment of Chairman. Rescheduled the meeting when there was more Councillors able to attend. Due to timescales, we excluded some of the items on the agenda. These will be carried over to the next meeting.

#### 1. To appoint a Chairman:

- a. The chairman was appointed as the existing Chairman, Cllr Ansell, was agreed (Prop: JA; Sec: JH) all in agreement.
- b. Chairman to sign the declaration of office for chairman signed

# 2. To appoint a Vice Chairman: The Vice Chairman was appointed as the existing Vice-Chair, CIIr Ashfield was agreed. (Prop: JH; Sec: IA) all in agreement.

It was also noted that Cllr Wade had shown an interest in becoming the vice chair. It was agreed that he would be a Vice Chair in training.

- h. To agree Section 2 of the AGAR Accounting Statement, page 5. This was also discussed and agreed.
- Issues from Councillors (for information only). Cllr Shave has requested that the Parish Council pay for the bill of the reed screening. The bill was for £54.95, to LL. This will be approved at the Finance section.
- **j.** Clerk's report: The Clerk reported that the Parish Council should be inspecting the play equipment on a regular basis, even though the equipment is new and under warranty. The Clerk stated that Norfolk Parish Training and Support offer playground inspection training. This may need to be considered.
