# **Extra-Ordinary Meeting of the Parish Council**

#### 1. Chairman's Welcome

- a. To receive apologies for absence. Cllr Crowfoot did not show.
- b. To receive declarations of interest other than those registered with South Norfolk District Council. Cllr Ansell declared an interest in 5a, as this may directly impact him.
- c. To record the number of members of the public present. 3

### 2. Minutes of last meeting

a. The approval of previous meetings will be approved when we have face to face meetings.

### 3. Matters to be discussed at this virtual meeting

- a. To receive an update on the Internal Audit. Due to COVID-19, it was agreed that the internal audit report would be sent by courier.
- b. To agree for the External Audit to be an Exempt Audit again this year. This was agreed and (Prop: JA; Sec: IA) all in agreement.
- c. To receive an update on the Mutual Aid Community Hub, and agree any action. There has been no problems, so far. We managed to obtain a £1000 grant. Village Hall stock is still ok. Cllr Ansell expressed a thanks to all involved in the Mutual Aid.
- d. To note that due to the current COVID-19 Lockdown there will be no Annual meetings this year. Therefore, the existing Chairman and Vice Chairman will continue to May 2021. This was noted.
- 4. Chairperson's report No report.

#### 5. Planning Applications, to discuss the following and agree any action:

a. BA/2019/0412/FUL: Three Rivers Camp Site: Demolition of service sheds and container; erection of new service building; shower room extension to boatshed; enlargement of basin and pontoon to provide mobility access and mooring/charging for electric day boats and visitor berth; play area; increase in number of caravan standings from 12 to 20; hard surface path to South end of site to provide mobility access; improved slipway. – Noticed an increase from 12 to 20. Is there a consideration for disabled facilities? The land immediately adjacent to the site is a formally designated County Wildlife Site. The marshes immediately beyond this site are designated as a SSSI and Ramsar Site. Agreed to recommend Objection. (Prop: LK; Sec: LR). All in agreement.

b. South Norfolk 2020/0689: Land South of Little Row, The Street: Erection of single detached house with associated landscaping, (resubmission of 2019/2188). This is a piece of land behind the village hall. The building proposed, appears to be done very carefully, especially in the conservation area. There are concerns over the overshadowing for the neighbours. 3 councillors recommended approval; 2 councillors were neutral. Therefore, it was agreed to recommend Approval.
